## **PUBLIC HEARING:**

 Conditional Use – 15912 West High Street Amusement Arcade: Ms. McCoy stated that Mr. Carrabine has proposed a children's arcade. Included in the packet is a drawing showing the proposed layout. Mr. Linberg asked Ms. McCoy if there was an issue with parking. Ms. McCoy stated that there is no issue with parking due to the parking lot being included in the strip center. Mr. Carrabine stated that he ran the arcade at Conneaut Lake Park. The youth have nothing to do especially during the winter, Middlefield feels like a great place for a business like this. This will be a partial ticket redemption arcade; turn in ticket to receive prizes. This will be a family, teenage and kid friendly arcade with a small snack bar. Mr. Brant Smith- Marbran Properties stated that there are several conditions in the lease that will protect the village and Marbran properties. Feels that this business will be a benefit to the village, especially for the families. Mr. Carrabine will start out with hours of 2 pm to 10 pm on Thursday through Saturday and earlier closing on Sunday. Might have additional hours in the summer. Mr. Lee stated that the commission should incorporate the lease agreement into the approval. The village ordinance stated that any child under 12 must be accompanied by a parent. The arcade will have to comply with any conditions that the Police Department may impose should the need arise. The arcade will need to abide by the village's curfew laws. The arcade will be run by the owner and 2 staff members. The space that the arcade will occupy is approximately 3100 feet. Mayor Garlich opened the public hearing at 7:25 pm. There being no comments from the audience. Mayor Garlich closed the public hearing at 7:25 pm.
