The Finance & Ordinance meeting was called to order at 6:00 p.m. with the following members present: Mr. Sam Morrow, Mr. Scott Klein and Ms. Kaitlyn Arganti.

<u>Approval of Minutes:</u> April 5, 2018 meeting minutes were presented for approval. Ms. Arganti made a motion to approve the minutes as presented, motion seconded by Mr. Klein. All in favor: Yeas (3)

OLD BUSINESS

1. Village Finances – Discussion: Ended up being a pretty good month for tax collection; up from last year. All the revenue sources are up compared to last year. Expenses are still down and collections are still up. Payroll is trending about \$53,000 compared to last year. Will probably end up around \$20,000.00; had a lot of overtime and also the police department is fully staffed. Mr. Giardina stated that he met with Home Saving and they are offering a pretty high yield interest rate. Currently have money in Huntington. Would like to see if Huntington will match the rate or if the committee would be willing to transfer the investment to Home Savings. Rates are increasing for the CD's but still pretty low.

NEW BUSINESS

- Senior Discount for Utilities: Ms. McCoy stated that she would like to have a
 discussion regarding giving renters the ability to get the discount also. This would
 change the Ordinance to read that the residence does not have to be owner occupied.
 Will make a resolution and bring it back next month.
- 2. Resolution 18-16 A Resolution Designating June 2018 Obesity Awareness Month, and June 14, 2018 Middlefield Means Health Day, and Declaring an Emergency: No discussion held. Mr. Klein made a motion to recommend Resolution 18-16 to Council, motion seconded by Ms. Arganti. All in favor: Yeas (3).
- 3. Resolution 18-17 A Resolution Authorizing the Purchase of Specified Insurance from Love Insurance Agency, and Declaring an Emergency: Ms. McCoy stated that this is our liability Insurance. The policy went up a little bit due to the property values going up and also included a beefed up the cyber security policy. About 2.7% increase. Chief Tucholski stated that when it comes to Cyber security there cannot be enough. Mr. Arganti made a motion to recommend Resolution 18-17 to Council, motion seconded by Mr. Klein. All in favor: Yeas (3). Discussion regarding the fact that no other companies will bid the product due to so many claims. Had several claims within 5 years.
