Mr. Giardina stated water and sewer are up compared to the prior year and income tax is slightly down compared to the prior year. Mr. Giardina stated total receipts are up overall and expenses are down. Mr. Giardina stated individual income tax is strong in the Village due to wages going up. Mr. Giardina stated withholdings are also up compared to a year ago and the infrastructure fund is positive.
- **6. <u>AMBULANCE REPORT</u>** Report is included in the packet. Mayor Garlich stated they did by a new ambulance unit.
- 7. **FIRE DEPARTMENT REPORT** Report is included in the packet.
- **8. ECONOMIC DEVELOPMENT:** Report is included in the packet. Ms. McCoy stated she has been working on finishing up the Hartville Hardware project. Ms. McCoy stated her and Mr. Boksansky met with the owners of the Rite Aid building for potential ideas for that property. Mayor Garlich recommended replenishing the Storefront Renovation Program fund, there are a lot of benefits to this. Ms. McCoy stated Mr. Giardina would need to create a new line fund under General. Mr. McConnville recommended making an ordinance to make it easier for auditing purposes.
- **9. ZONING REPORT:** Report included is included in packet. Mr. Boksansky stated for the month of March he was able to issue 11 out of 12 zoning permits. Middlefield Tavern would like to place some tables in front of the mural for people to sit at. Mayor Garlich told Mr. Boksansky to meet with the property owner and get a proposal. Mr. McConnville stated since it is Village property he recommends coming up with a lease that has rules and regulations.

plants. The guys have been street sweeping, brush pickup has started. Chief Tucholski stated the service garage driveway will be repaired. Chief Tucholski stated lawn mowing started at the parks and municipal building.

Discussion held regarding the huskie locker and possibly accepting donations to purchase things the locker needs.
