The Finance & Ordinance meeting was called to order at 6:00 pm with the following members present: Ms. Kaitlyn Arganti, Mr. Bill Blue, and Mr. Scott Klein.

<u>Also present:</u> Mayor Garlich, Leslie McCoy- Village Administrator, Mr. Nick Giardina- Fiscal Officer, and Chief Tucholski.

<u>Approval of Minutes:</u> April 11, 2024 meeting minutes were presented for approval. *Mr. Klein made a motion to approve the minutes as presented, motion seconded by Ms. Arganti. All in favor: Yeas (3).*

OLD BUSINESS

1. **Village Finances – Discussion:** Mr. Giardina stated water and sewer compared to the previous year is up about \$3,000. Income tax is down but overall revenue for water, sewer, and income tax are up slightly compared to a year ago. Mr. Giardina stated total receipts are up compared to a year ago and the total net between all categories is up compared to the prior year. Mr. Giardina stated there was a reimbursement that came in for the well project. Mr. Giardina stated the Village is still spending less than the revenue being brought in. Mr. Giardina stated overall finances in the Village are good.
